*Vehicles will not be allowed to leave until the conclusion of the show.

*Please abide by the rules listed and rules to follow. Failure to abide may result in expulsion and disqualification.

Judging:

A score card from 1-10 will be made for each class of entrants. Classes will be combined if not enough entries in each class. There will be three judges for this competition. At the conclusion of the judging session all score cards will be tallied to determine winner in each class. The entrant with the most points in each class will be declared the winner along with the 2nd and 3rd place winners. Should there be a tie the three judges will then vote on a winner. The entrant who receives two out of three votes will be declared the winner.

Waiver:
